ORDINANCE NUMBER: 2018-006

**AN ORDINANCE OF THE CARENCRO
CITY COUNCIL AMENDING THE
CARENCRO CODE OF ORDINANCES
REGARDING GARBAGE CONTAINERS**

BE IT ORDAINED by the Carencro City Council that:

SECTION 1:

It has come to the attention of the City Administration that empty solid waste containers are, in some cases, being left on city streets following the emptying of such containers through the scheduled collection of solid waste, such that these containers not only detract from the orderly appearance of the city's residential neighborhoods, but they also present an impediment and danger to the safe and unobstructed pedestrian and vehicular use of the city's streets. In response to this situation, the Carencro City Council ("Council") now finds it necessary and expedient to amend the Carencro Code of Ordinances (Code) relative to collection of garbage in order to enhance both the safety and enjoyment its citizens' use of streets of the City of Carencro.

SECTION 2:

In consideration of Section 1 above, the Council hereby amends Chapter 58, "SOLID WASTE", Article II, "COLLECTION AND DISPOSAL", Section 58-30, "Collection of garbage", of the Carencro Code of Ordinances, by adding to said section paragraph (e), which said paragraph shall follow immediately after paragraph (d) as the last paragraph of Section 58-31, with the said paragraph (e) to hereafter read as follows:

"(e) Containers are to be removed from the street within 24 hours after being emptied. Customers not complying with such requirements will receive two written warnings, and after each additional violation, a \$25.00 fine will be assessed."

SECTION 3: EFFECTIVE DATE OF ORDINANCE:

This ordinance shall become effective immediately upon return of the ordinance to the City Clerk (after execution by the Mayor), on the tenth (10th) day after receipt of the ordinance by the Mayor without signature or veto, or upon an override of a veto, whichever occurs first.

SECTION 4: REPEALER:

Any City of Carencro ordinance or parts thereof in conflict herewith are hereby repealed.

SECTION 2: The Carencro Police Department Pay Plan, attached hereto and made a part hereof as Exhibit "A", shall be implemented in accordance with the Carencro Police Department Pay Plan, Rules for Administration, attached hereto and made a part hereof as Exhibit "B".

SECTION 3: This ordinance shall become effective on July 29, 2018. The City of Carencro budget for fiscal year 2017-2018 is hereby amended to appropriate the monies necessary to fund this newly adopted pay plan.

SECTION 4: All ordinances or resolutions, or parts thereof, in conflict herewith, are hereby repealed.
