1. **ORDINANCE NO. 2008-004:** AN ORDINANCE OF THE CARENCRO CITY COUNCIL AUTHORIZING MAYOR GLENN L. BRASSEAU TO EXECUTE DOCUMENTS WHEREBY THE CITY OF CARENCRO SHALL ACQUIRE FROM WILLIAM A. DUPON, M.D., FEE TITLE TO IMMOVABLE PROPERTY, THE SIZE OF SAID PROPERTY TO BE DETERMINED BY SURVEY.

3. **ORDINANCE NO. 2008-021:** AN ORDINANCE OF THE CARENCRO CITY COUNCIL ADOPTING AN OPERATING BUDGET OF REVENUE AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING DECEMBER 1, 2008 AND ENDING NOVEMBER 30, 2009 AND AMENDING THE OPERATING BUDGET OF REVENUES AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING DECEMBER 1, 2007 AND ENDING NOVEMBER 30, 2008. DEFER TO NOVEMBER 24, 2008 SPECIAL MEETING.

AT THE CITY HALL TO ALLOW CITIZENS TO PROVIDE COMMENTS AND OPINIONS ON THE PROPOSED BUDGET OF THE CITY OF CARENCRO FOR THE FISCAL YEAR BEGINNING DECEMBER 1, 2008, AND ENDING NOVEMBER 30, 2009. IN ADDITION PROPOSED AMENDMENTS TO THE BUDGET OF THE CITY OF CARENCRO FOR THE FISCAL YEAR ENDING NOVEMBER 30, 2008, MAY BE CONSIDERED.

IMMEDIATELY FOLLOWING THE PUBLIC HEARING A SPECIAL CARENCRO CITY COUNCIL MEETING IS SCHEDULED AT 6:00 P.M. AT THE CITY HALL TO ADOPT THE BUDGET DOCUMENT.

4. **ORDINANCE NO. 2008-022:** AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING THE CARENCRO CODE OF ORDINANCES, CHAPTER 74, ARTICLE II, SECTION 74-37, ADDING A NEW SUB-PARAGRAPH (b), PROHIBITING VEHICLES HAVING MORE THAN THREE AXLES ON THE DRIVEWAY LEADING TO THE COMMUNITY CENTER AND LIBRARY AND ON CENTENNIAL DRIVE AND ESTABLISHING A PENALTY FOR VIOLATIONS.

5. **ORDINANCE NO. 2008-023:** AN ORDINANCE OF THE CARENCRO CITY COUNCIL AUTHORIZING A CONTRACT BETWEEN THE CITY OF CARENCRO AND ALLIED WASTE SERVICES OF ACADIANA (FORMERLY BFI WASTE SYSTEMS OF NORTH AMERICA, INC) PROVIDING FOR THE COLLECTION AND DISPOSAL OF SOLID WASTE TO INCLUDE PROVISION OF AUTOMATED RESIDENTIAL SOLID WASTE COLLECTION SERVICES.
