1. **ORDINANCE NO. 2008-018 (DRAFT #4)** AN ORDINANCE ESTABLISHING PERFORMANCE LAND-USE REGULATIONS WITHIN THE CITY LIMITS OF THE CITY OF CARENCRO, LOUISIANA.

2. **ORDINANCE NO. 2008-020** AN ORDINANCE OF THE CARENCRO CITY COUNCIL AUTHORIZING THE EXCHANGE OF IMMOVABLE PUBLIC PROPERTY OWNED BY THE CITY OF CARENCRO FOR IMMOVABLE PRIVATE PROPERTY OWNED BY PAUL MARTIN.

This ordinance was adopted on October 20, 2008 and proper notice to the public was given. Subsequent to final adoption, a decision was made to give further public notice of the exchange of property by having a public notice published on three separate days within 15 days. Notices were published on Nov. 26, Dec. 4, and Dec. 11, 2008. COUNCIL ACTION IS REQUESTED FOR COUNCIL TO VOTE TO RATIFY ORDINANCE 2008-020.

3. **ORDINANCE NO. 2008-027** An ordinance of the Carencro City Council amending the Code of Ordinances, Chapter 14, Buildings and Building Regulations, Article III Building Standards, Division 8 Permits and Inspections, Section 14-271, adding sub-paragraph (c), Expiration of Building Permits.

4. **ORDINANCE NO. 2008-028** An ordinance of the Carencro City Council amending Section 62-34(a) of the Code of Ordinances decreasing width of sidewalks from five to four feet and adding a new Section 62-65 (a) thru (d) procedures for construction of sidewalks in public right of way.
