ORDINANCES FOR FINAL ADOPTION:

1. ORDINANCE NO. 2009-026: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AUTHORIZING MAYOR GLENN L. BRASSEAU, TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE LAFAYETTE CONSOLIDATED GOVERNMENT TO PROVIDE FUNDING FOR THE COMPLETION OF A STUDY BY THE UNITED STATES ARMY CORP OF ENGINEERS CONCERNING DRAINAGE IMPROVEMENTS TO BEAU BASIN COULEE.

ORDINANCE NO. 2009-28: AN ORDINANCE OF THE CITY OF CARENCRO, LOUISIANA, GRANTING TO ATMOS ENERGY CORPORATION (A TEXAS AND VIRGINIA CORPORTATION WITH ITS PRINCIPAL OFFICE IN THE CITY OF DALLAS, DALLAS COUNTY, TEXAS) AND ITS SUCCESSORS AND ASSIGNS THE FRANCHISE AND RIGHTS TO CONDUCT IN SUCH TOWN THE BUSINESS OF ACQUIRING, MAINTAINING, CONSTRUCTING, LAYING, REPAIRING, REMOVING, REPLACING, INSTALLING, OPERATING, AND DISPOSING OF A GAS SYSTEM FOR THE SALE, TRANSPORTATION, AND DISTRIBUTION OF NATURAL GAS WITHIN AND BEYOND THE MUNICIPAL BOUNDARIES OF THE TOWN AND TO THE RESIDENTS AND BUSINESSES LOCATED THEREIN FOR LIGHT, HEAT, POWER, AND ANY OTHER PURPOSES AND THE RIGHT TO USE THE PRESENT AND FUTURE STREETS, ROADS, HIGHWAY, ALLEYS, BRIDGES, PUBLIC WAYS, AND IMMOVABLE PROPERTY IN SUCH TOWN AND OWNED OR CONTROLLED BY SUCH TOWN FOR SUCH PURPOSES: PRESCRIBING THE TERMS AND CONDITIONS TO WHICH SUCH FRANCHISE AND RIGHTS ARE SUBJECT: AND PRESCRIBING THE TERM OF SUCH FRANCHISE AND RIGHTS.

3. ORDINANCE NO. 2009-029: AN ORDINANCE OF THE CITY OF CARENCRO AUTHORIZING SALE BY THE CITY OF A PORTION OF THE OLD UNION PACIFIC RAILROAD RIGHT-OF-WAY PROPERTY WHICH IS NO LONGER NEEDED FOR PUBLIC PURPOSES.
