1. ORDINANCE NO. 2010-009: AN ORDINANCE OF THE CARENCRO CITY COUNCIL REPEALING ORDINANCE NO. 2010-003 CONCERNING AMENDMENTS TO CHAPTER 10, ARTICLE III HORSES, MULES OR ANIMAL DRAWN VEHICLES, AND OTHER MATTERS RELATING THERETO.

H. ORDINANCES FOR FINAL ADOPTION:

1. ORDINANCE NO. 2010-005: AN ORDINANCE OF THE CARENCRO CITY COUNCIL ADOPTING AN ADJUSTED MILLAGE RATE OF 3.96 MILLS TO BE LEVIED UPON THE DOLLAR OF THE ASSESSED VALUATION OF ALL PROPERTY SUBJECT TO AD VALOREM TAXATION WITHIN THE CITY OF CARENCRO, PARISH OF LAFAYETTE FOR THE YEAR 2010 FOR THE PURPOSE OF RAISING REVENUE.

2. ORDINANCE NO. 2010-006: AN ORDINANCE OF THE CARENCRO CITY COUNCIL INCREASING THE MILLAGE RATE, BUT NOT IN EXCESS OF THE PRIOR YEAR'S MAXIMUM RATE ON ALL TAXABLE PROPERTY SHOWN ON THE OFFICIAL ASSESSMENT ROLL FOR THE YEAR 2010, AND WHEN COLLECTED, THE REVENUES FROM SAID TAXES SHALL BE USED ONLY FOR THE SPECIFIC PURPOSES FOR WHICH SAID TAXES HAVE BEEN LEVIED.

3. ORDINANCE NO. 2010-007: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AMENDING THE CODE OF ORDINANCES, CHAPTER 78, ARTICLE 1, GENERAL, ADDING A NEW SECTION 78-4 (a) AND (b) PROHIBITING THE USE OF ANY EQUIPMENT OR DEVICE ON THE PREMISES OF ANY CUSTOMER WHICH WOULD RESULT IN THE THEFT OF CITY UTILITIES.

4. ORDINANCE NO. 2010-008: AN ORDINANCE OF THE CARENCRO CITY COUNCIL AUTHORIZING AMENDMENT OF THE CONTRACT BETWEEN THE PARKS AND RECREATION COMMISSION OF CARENCRO, INC., (COMMISSION) AND THE CITY OF CARENCRO TO ELIMINATE THE COMMISSION'S LEASE PAYMENT OBLIGATION.
