ORDINANCE FOR FINAL ADOPTION:

Ordinance No. 2011-020: An ordinance providing for the incurring debt and issuance of One Million Dollars (\$1,000,000) of Sales Tax Bonds, Series 2011, of the I-49 Corridor Economic Development District, State of Louisiana; prescribing the form, terms and conditions of said Bonds; designating the date, denomination and place of payment of said Bonds; providing for the payment thereof in principal and interest; authorizing the agreement with the Paying Agent; and providing for other matters in connection therewith.

Council member Guidry made the motion to final adopt Ordinance No. 2011-020 including accepting the bid from Iberia Bank at an interest rate of 2.68%; seconded by Council member Sinegal; motion approved.

INTROUDCTORY ORDINANCE:

Ordinance No. 2011-025: An ordinance of the Carencro City Council authorizing the City of Carencro to enter into an agreement with Marco Oil, Inc. by which the city will acquire property needed for the Hector Connoly roundabout in exchange for the city providing improvements to a portion of East Angelle Street.

Council member Babineaux made the motion to introduce Ordinance No. 2011-025; seconded by Council member Boudreaux; motion approved.

RESOLUTION:

A resolution of the Carencro City Council requesting that the U. S. Postal Services retain the current services it provides at the Moss Street Location.

Council member Richard made the motion to approve the resolution; seconded by Council member Babineaux; motion approved.

A resolution of the approving the appointment of a Director and an Alternate Director to represent the City of Carencro, State of Louisiana, on the Board of Directors of the Louisiana Municipal Natural Gas Purchasing and Distribution Authority as provided by Chapter 10-b of Title 33 of the Louisiana revised statues of 1950.

Council member Richard made the motion to approve the resolution appointing Mayor Glenn L. Brasseaux as Director and Gwen B. Martin as Alternate Director; seconded by Council member Guidry; motion approved.

Council member Guidry made the motion to adjourn the meeting; seconded by Council member Babineaux; motion approved.
