1. A RESOLUTION [WHEREAS THE CITY IS IN NEED OF IMPROVEMENTS TO CITY OF CARENCRO WATER SYSTEM WHOSE PWS NO. IS LA 1055005] AUTHORIZING MAYOR GLENN L. BRASSEAUX TO SUBMIT LOAN APPLICATION AND ACCOMPANYING DOCUMENTS TO THE DEPARTMENT OF HEALTH AND HOSPITALS ON BEHALF OF THE CITY OF CARENCRO FOR THE PURPOSE OF PLACING THIS PROJECT ON THE COMPREHENSIVE PRIORITY LIST FOR FUNDING THROUGH THE DRINKING WATER REVOLVING LOAN FUND PROGRAM AND TO DESIGNATE MAYOR GLENN L. BRASSEAUX AS THE OFFICIAL PROJECT REPRESENTATIVE.

2. AS RESOLUTION [whereas the City of Carencro is in need of an Automatic Meter Reading and Advanced Meter Infrastructure System for the water distribution system, a portable generator and associated equipment necessary to power wastewater lift stations during power outages, lift station replacement pumps for the Francois Street Wastewater Lift Station, painting of the Manola Street and Post Road Wastewater Treatment Plants, installation of a new 500,000 gallon equalization basin at the Manola Wastewater Treatment Plant, replacement of existing headworks at Post Road Wastewater Treatment Plant and the installation of PLC's for the SCADA system required to perform automatic metering and record keeping for all wastewater lift stations within the City of Carencro] authorizing Mayor Glenn L. Brasseaux to submit a pre-application to the department of environmental Quality and such additional information that may be requested on behalf of the city of carencro for the purpose of placing this project on the project priority list for funding through the state revolving fund loan program AND TO DESIGNATE MAYOR GLENN L. BRASSEAUX AS THE OFFICIAL PROJECT REPRESENTATIVE .
