



CITY COUNCIL MEETING MINUTES

Mayor Glenn L. Brasseaux called the meeting to order at 6:10 p.m. Councilman Coach Allen Conque led the Pledge followed by a moment of silent prayer.

Council Members in attendance were Antoine Babineaux, L.J. Boudreaux, Coach Allen Conque, Kim Guidry and J.L. Richard.

FINAL ADOPTION OF ORDINANCES

ORDINANCE NO. 2008-021 An ordinance of the Carencro City Council adopting an Operating Budget of Revenue and Expenditures for the fiscal year beginning December 1, 2008 and ending November 30, 2009 and amending the Operating Budget of Revenues and Expenditures for the Fiscal Year Beginning December 1, 2007 and ending November 30, 2008.

With no comments Councilman L.J. Boudreaux made a motion for final adoption; seconded by Councilman J.L. Richard.

After some discussion Councilwoman Kim Guidry made a substitute motion to adopt Ordinance 2008-021 as presented with the exception of excluding the pay raise for the council members; seconded by J.L. Richard; those in favor were Council members Babineaux, Boudreaux, Guidry, and Richard; opposed, was Councilman Conque; motion approved.

Councilman Conque expressed concern of some of the expense classification of the Parks and Recreation Commission of Carencro (P.A.R.C.) and Pelican Park. Mayor Brasseaux would like to have a meeting to address these concerns with all involved parties present.

Following a discussion and with no comments from the public, a motion to approve the Operating Budget of Revenue and Expenditures for the fiscal year beginning December 1, 2008 and ending November 30, 2009 and amending the Operating Budget of Revenues and Expenditures for the Fiscal Year Beginning December 1, 2007 and ending November 30, 2008 for the Parks and Recreation Commission of Carencro (P.A.R.C.) was made by Councilman Babineaux; second by Councilman Boudreaux; those in favor were Council members Babineaux, Boudreaux, Guidry, and Richard; opposed, was Councilman Conque; motion approved.

A motion to approve the Operating Budget of Revenue and Expenditures for the fiscal year beginning December 1, 2008 and ending November 30, 2009 and amending the Operating Budget of Revenues and Expenditures for the Fiscal Year Beginning December 1, 2007 and ending November 30, 2008 for Pelican Park was made by Councilman Babineaux; second by Councilman Boudreaux; those in favor were Council members Babineaux, Boudreaux, Guidry, and Richard; opposed was Councilman Conque; motion approved.

With no further business or comments, the meeting was adjourned at 6:30 p.m.
