**EMERGENCY ORDER**

In light of the COVID-19 public health emergency, the state of emergency declaration issued by Governor John Bel Edwards on March 13, 2020, the recommendations issued on March 12, 2020 by the Louisiana Supreme Court and the guidelines set forth by the Center for Disease Control, the Court issues the following Order for Carencro Mayor's Court:

Any and all arraignments and trials set for any date in March, 2020, and specifically March 19 arraignments and March 26 trials are hereby continued and will be rescheduled as follows:

March 19, 2020 arraignments are continued until April 16, 2020. All those who are under Summons to appear on March 19, 2020 must now appear on April 16, 2020;

March 26, 2020 trials are hereby continued and will be rescheduled on April 30, 2020. All people under Summons to appear for trial on March 26, 2020 must now appear on April 30, 2020.

All court dates after April 1, 2020 remain intact.

This Order shall remain in effect until further Order of this Court.
