ORDINANCE NO: 2021-002

**AN ORDINANCE OF THE CARENCRO CITY COUNCIL
AMENDING ORDINANCE NO. 2000-012 AND THE CARENCRO CODE OF
ORDINANCES IN
REGARDS TO THE SUBSTANCE ABUSE POLICY**

BE IT ORDAINED by the City Council of the City of Carencro:

SECTION 1: CITY OF CARENCRO SUBSTANCE ABUSE POLICY:

The Carencro City Council now finds it necessary to amend Ordinance No. 2000-12 and the Carencro Code of Ordinances: Appendix C-Personnel Policy and Procedures, Addendum 4-Drug and Alcohol testing.

SECTION 2:

In consideration of Section 1 above, Ordinance No. 2000-012, under B. employee. Number 2 is hereby amended by adding “Employees shall enroll within 30 days of the first day of suspension into a rehabilitation program” such that paragraph shall hereinafter read as follows:

2. All employees testing positive in the above circumstances will be suspended without pay and permitted to go through a rehabilitation program at his or her expense. If employee refuses to attend rehabilitation or does not successfully complete such a program, they will be terminated. Employees shall enroll within 30 days of the first day of suspension into a rehabilitation program.

SECTION 3:

In consideration of Section 1 above, under B, employees. Number 4 is hereby amended by removing the words “for a period of five years”, such that paragraph shall hereinafter shall read as follows:

4. After returning to work the employee will be subject to random testing at the discretion of the City of Carencro.

SECTION 3: EFFECTIVE DATE OF ORDINANCE:

This ordinance shall become effective immediately upon return of the ordinance to the City Clerk (after execution by the Mayor), on the tenth (10th) day after receipt of the ordinance by the Mayor without signature or veto, or upon an override of a veto, whichever occurs first.

SECTION 4: REPEALER:

Any City of Carencro ordinance or parts thereof in conflict herewith are hereby repealed.
